

The function of the Anti-Ragging Committee shall be as under:

- 1) To root out ragging in all its forms from the Institute by prohibiting it by law; preventing its occurrence by following the provisions of these regulations and punishing those who indulge in the same despite of 'prohibition and prevention' as provided for in these regulations & the appropriate law in force.
- 2) The Anti-ragging Committee shall also review the efforts made by such departments to publicize anti-ragging measures, cross-verify the receipt of undertaking from student and their parents / guardians every year and shall be the prime mover for initiating action by the Institute authorized to suitably amend the statutes or ordinances or bye-laws to facilitate the implementation of anti-ragging measures at the level of the Institute.
